Shall the Polo R-VII School District issue its general obligation bonds in the amount of \$1,950,000 for the purpose of constructing, improving, renovating, repairing, furnishing and equipping new and existing school facilities, with an emphasis on safety and security upgrades as well as handicapped accessibility, including constructing a new secure entrance to the outdoor activity facilities which would include storage space and handicap accessible restrooms?

Approval of this question is estimated to result in no increase to the District's current debt service property tax levy, which is estimated to remain at \$1.1101 per one hundred dollars of assessed valuation of real and personal property.
