CALDWELL COUNTY COMMISSION MEETING

Tuesday, August 29, 2023

1. CALL TO ORDER

Commissioner Dale Akey called the meeting to order at 8:30 A.M.

2. ROLL CALL

4. APPROVAL OF AGENDA/MINUTES
