### CALDWELL COUNTY COMMISSION MEETING

Tuesday, February 21, 2023

**1. CALL TO ORDER**

Commissioner Dale Akey called the meeting to order at 8:30 A.M.

Commissioners participated in a Zoom call with Allstate to discuss LOC construction updates. They agreed to start having bi-weekly meetings.

Tony Figg from Green Hills Communications met with the commissioners to discuss IT for the courthouse.

Commissioners met with John Deis concerning the LOC Recreation Plan and a \$3,000 contract.


Beverly Alden discussed a building permit refund of \$492.20, for permits 1274 & 1288.




## 6. ADJOURNMENT
