### **CALDWELL COUNTY COMMISSION MEETING**

Tuesday, June 20, 2023

#### **1. CALL TO ORDER**

Commissioner Dale Akey called the meeting to order at 8:30 A.M.

#### **4. APPROVAL OF AGENDA/MINUTES**

Commissioner Hibler moved to approve the agenda. Commissioner Akey seconded the motion. A roll call vote was taken, Commissioner Akey-yes; Commissioner Hibler-yes. The motion passed.

#### **5. REGULAR AGENDA**

Jeff Campbell with Road & Bridge met with commissioners to report that a box culvert on Ironwood is falling in. They discussed replacing it with an alum box culvert or arced tubes. They also discussed sending a letter to have equipment moved off the county right of way. Jeff reported that the Little Otter Creek pollinators had been mowed.

Melissa Poje with Road & Bridge joined the meeting to present bids from Davidson Tree Care, LLC for brush removal. Commissioner Abbott moved to send certified letters for the bid amounts to the property owners. Commissioner Akey seconded the motion. A roll call vote was taken, Commissioner Abbott-yes; Commissioner Hibler-yes; Commissioner Akey-yes. The motion passed.

Commissioners met with Mark Merrill with Emergency Management to review the bid for storm shelters to be purchased with ARPA funds.

Pat Daniels, a citizen of Caldwell County met with the commissioners to discuss several complaints. She reported a complaint with the sheriff's office. MS. Daniels had a complaint about a ditch on Ore Road and dirt piled up on the side of the road, as well as a brush law violation. She also discussed recording meetings. The commissioners will investigate her brush law violation as well as the complaint about the issues on Ore Road.

Chelsea Corkins, Charla Daniel, and Manoj Chhetri from the Caldwell County Extension office came to introduce themselves and give updates on the University Extension.

Commissioner Hibler left the meeting at 10:00 a.m.
