CALDWELL COUNTY COMMISSION MEETING

Tuesday, May 09, 2023

1. CALL TO ORDER

Commissioner Dale Akey called the meeting to order at 8:30 A.M.

2. ROLL CALL

4. APPROVAL OF AGENDA/MINUTES

Commissioner Hibler moved to approve the agenda. Commissioner Akey seconded.

Beverly Alden, Assessor met with commissioners to discuss taxing roll off dumpsters. She reported that she would be sending out BOE letters by June 15th and the BOE meeting would be held on July 17, 2023. The commissioners were informed of BOE training by the State Tax Commission.

Commissioners met with Sheriff, Mitch Allen to discuss the need for all receipts to be turned in to get reimbursement.

Steve Rasmussen from the City of Cameron met with commissioners to give an update.

Commissioner Abbott moved to approve the Court Order from Beth Larkins, Collector/Treasurer to outlaw taxes. Commissioner Hibler seconded the motion. Roll call vote: Commissioner Akey-yes; Commissioner Abbott-yes; Commissioner Hibler-yes. The motion passes.

Commissioners met with Terry Rumery to discuss Economic Development in the county.

Commissioners called Tony Figg of Greenhills to discuss the IT transition.

Commissioner Akey signed Brookfield Box & Bridge Change Order #3 for \$24,000.

Commissioner Akey signed NRCS reimbursement #18 and MWRP reimbursement #7.

Commissioner Akey signed a letter of support for USDA RD Rural Housing Preservation Grant Application being submitted by Green Hills Rural Development, Inc.

6. ADJOURNMENT


With no other business before the Commission, the meeting was adjourned at 11:30 a.m.




