### **CALDWELL COUNTY COMMISSION MEETING**

Thursday, October 19, 2023

#### **1. CALL TO ORDER**

Commissioner Dale Akey called the meeting to order at 8:30 A.M.

#### **4. APPROVAL OF AGENDA/MINUTES**

Commissioner Hibler moved to approve the agenda. Commissioner Akey seconded the motion. A roll call vote was taken, Commissioner Akey-yes; Commissioner Hibler-yes. The motion passed.

#### **5. REGULAR AGENDA**

Commissioners met with Jeff Campbell with Road & Bridge. Jeff reported the corn on Little Otter Creek property had been combined. Jeff and the commissioners discussed putting \$600,000 of Road & Bridge funds in CDs and \$100,000 of Gravel Sales Tax Funds in a CD. Commissioner Hibler moved to sign court orders to move money from the Road & Bridge fund and the Gravel Sales Tax fund to CDs. Commissioner Akey seconded the motion. A roll call vote was taken, Commissioner Akey-yes; Commissioner Hibler-yes. The motion passed.

Commissioners returned a call from Ray Dockery to answer questions about access to a property from Thiel Road.

Commissioners called Kerry Irons of Adventure Cycling Association upon his request. Kerry was giving information about a possible bike trail in our county. He requested the commissioners consider writing a letter of support for the proposed project and noted there was a deadline of March 2024.

Commissioners met with Colt Arnold of Buildings & Grounds/Planning & Zoning to discuss the broken windshield on the county Explorer and low tire on the county car. They also discussed the need for a water spicket to be put in for the boiler system.

Commissioner Hibler moved to go to closed session per RSMO 610.021 to discuss personnel matters. Commissioner Akey seconded the motion. A roll call vote was taken, Commissioner Akey-yes; Commissioner Hibler-yes. The motion passed.




