CALDWELL COUNTY COMMISSION MEETING

Tuesday, January 21, 2025

1. CALL TO ORDER

Commissioner Akey called the meeting to order at 8:30 a.m.

4. AGENDA

Commissioner Hibler moved to approve the agenda. Commissioner Howell seconded the motion. Commissioner Akey, Commissioner Hibler and Commissioner Howell voted in favor. The motion passed.

Commissioner Howell moved to approve the consent agenda. Commissioner Akey seconded the motion. A roll call vote was taken Commissioner Akey-yes, Commissioner Hibler-yes, Commissioner Howell-yes. The motion passed.

Commissioners met with Jeff Campbell and Melissa Poje with Road & Bridge to discuss a brush letter. Bridge replacements were also discussed. Melissa reported that the machine used to make road signs is outdated and the software won't download. The commissioners agreed to purchase a new Titan 3 machine for \$1900. Jeff reported that he and Dale would be going to Nebraska to pick up a Skid Steer trailer.

The construction schedule was discussed, and it was noted that tree clearing would begin on February 17, 2025. Commissioners asked for a Road Use Agreement as well as an updated Memorandum of Understanding. The next conference call will be at 10:30 a.m. on February 11, 2025.
