### **CALDWELL COUNTY COMMISSION MEETING**

Commissioners spoke to a representative from Enterprise Pipeline by phone to discuss a bond to cover any potential damage to county roads resulting from their replacement work on pipelines in the county.

It was discussed that the signs on propane tanks should be reviewed and updated with current emergency contact information.

Commissioners will advertise for bids to install new windows and window wells in the courthouse basement. Bids must be received by 8:45 a.m. on November 20, 2025. The bids will be opened at 9:00 a.m. on November 20, 2025 in the commission room of the courthouse.
