CALDWELL COUNTY COMMISSION MEETING

Tuesday, February 17, 2026

CALL TO ORDER

Presiding Commissioner Akey called the meeting to order at 8:30 a.m.

AGENDA

Commissioner Hibler moved to approve the agenda. Commissioner Howell seconded the motion. Commissioner Akey, Commissioner Hibler, and Commissioner Howell voted in favor. The motion passed.

Jeff Campbell, Road & Bridge Supervisor, was in attendance for the Rock and Culvert bid openings. One bid was received for aluminum box culverts from Viebrock Sales, LLC., and culvert bids priced per foot from Viebrock Sales, LLC., and Metal Culverts, Inc.

Commissioner Howell moved to accept the culvert bids from both Viebrock, LLC. and Metal Culverts, Inc. Commissioner Hibler seconded the motion. A roll call vote was taken, Commissioner Akey-yes; Commissioner Hibler-yes; Commissioner Howell-yes. The motion passed.

Two bids were received for rock: Tragers - \$15.35 per ton and Norris Quarries - \$16.25 per ton.

Commissioner Howell moved to accept the rock bids. Commissioner Akey seconded the motion. A roll call vote was taken, Commissioner Akey-yes; Commissioner Hibler-yes; Commissioner Howell-yes. The motion passed.

Jabob with IHP Industrial, Inc. met with the commission to discuss the steam pipe leak in

the basement. It was noted that the leak was the cause of water damage to the floor in the County Clerk's office.

Stephanie Henry, Planning & Zoning Coordinator reported that she had reorganized the Planning & Zoning ordinance book. She and the Commission discussed placing a newspaper advertisement for a Public Hearing scheduled in March. A lease for a small copier/printer/scanner for the Planning & Zoning Office was also discussed. The next Planning & Zoning meeting will be held at 7:00 p.m. on Thursday, March 12, 2026.






With no other business before the Commission, the meeting was adjourned at 9:45 a.m.
